

ASB Extended Care Contract Rates 2018-2019 School Year

Extended Care contract payment options. These options may be combined to come up with a single rate per family.	Monthly rate based on hours used per week.	*If max hours are used, this is the hourly rate.
<p><u>Extended Care Prepayment options</u> (per child; however in families with multiple children these hour packages may be shared between children in that family)</p> <p>Example: A family with two children each attending Extended Care for 6 hours a week, may select the 7-12 hour option and share these hours between the two children for \$264 as opposed to \$288 (the total cost of two 1-6 hour a week options).</p>

***Drop-in use of Extended Care is available on a limited basis, to accommodate minor emergencies, unavoidable conflicts or the occasional need. Prior to using Extended Care for drop-in childcare, it is necessary to communicate your need to Extended Care to ensure availability.**

****The non-registered rate will be applied to families that use Extended Care as a drop-in program, but have not turned in a registration form and/or have not communicated their need of Extended Care prior to the use of our program.**

ASB Extended Care Contract Rates **2018-2019 School Year** (continued)

Contract Rate notes:

- **Registration Fee will be waived** for all families that register for Extended Care and select a prepayment plan by June 1, 2018.
- All in-service days are included and not counted against a families monthly hours
- All conference days are included and not counted against a families monthly hours
- All half-days are included and not counted against a families monthly hours
- All payments are made via FACTS: Total annual amount will be paid over the 10-month tuition payment schedule or coordinated between family and Extended Care Director.
- Late fees will be applied to each family's balance and billed via incidental billing using FACTS

Drop-In Rate notes:

- All drop-in use of Extended Care will be rounded up to the next whole hour.
- \$9.00/hour drop-in use will require an Extended Care registration form and fee; drop-in use of Extended Care is not guaranteed, please check availability prior to use.
- If an Extended Care registration form is not turned in prior to family's use of Extended Care or that family has not communicated the need of Extended Care prior to use, that family will be billed at the \$16.00/hour drop-in rate.
- Drop-in use will be billed via incidental billing using the FACTS

Using the ASB Extended Care Enrollment Agreement and Contract Rate Worksheet, families will select the contract payment options for their childcare needs in the 2018-2019 school year. It is intended that these selections and the submission of the registration form is a contract for use during the 2018-2019 school year. A change to the selected hours may occur under the discretion of the ASB Extended Care Director and Principal, and in agreement with each family on a case-by-case basis.
